- Last year, departments and colleges were responsible for creating and facilitating cases in Interfolio. In AY 2023-2024, Faculty Affairs will create and shepherd cases through the internal review process, including overseeing candidate response periods.
- **Cases will be made available to you and faculty candidates by April 5th.** Once the cases are created, you and your faculty can begin uploading materials. You can also begin inviting external reviewers if you plan to use this function in Interfolio.
- Departments and colleges are still responsible for working with candidates to make sure their dossiers are complete before submitting them to our office. College and/or department case facilitators should work together to determine the workflow and timeline for checking candidate materials.
- All cases will follow the same schedule, including having the same candidate response periods at each level of review. Once cases are submitted to our office, the department and college will no longer be able to access the case until it is time to review the case.
- Departmental review committees (DRC), department heads (DH), college (or intercollegiate) review committees (CRC/IRC), and deans will have fixed periods of times to review cases, which are published below. If a case is submitted late at any level of review, the subsequent review period will be shortened accordingly.
